I, the undersigned, being first duly sworn on oath, do depose and say: that my name is

that I am an elector of the City of Alpharetta, eligible to vote in the election in which I am a candidate; that the name of the office I am seeking is Mayor (Council post number); that my date of birth is 10-29-1964; that I have been a legal resident of the State of Georgia for 25 years; that I have been a legal resident of the City of Alpharetta for 20 years; that I am a citizen of the United States; that I am eligible to hold such office; that I am a candidate for such office in the City of Alpharetta election to be held on the 22 day of May, 2018 that I have never been convicted and sentenced in any court of competent jurisdiction for fraudulent violation of primary or election laws, malfeasance in office, or felony involving moral turpitude and conviction of domestic violence under the laws of this State, any other State, or of the United States, or, if so convicted, that my civil rights have been restored; and at least ten years have elapsed from the date of the completion of the sentence without a subsequent conviction of another felony involving moral turpitude; and that I am not a defaulter for any federal, state, county, municipal, or school system taxes required of such office holder or candidate if such person has been finally adjudicated by a court of competent jurisdiction to own those taxes, but such ineligibility may be removed at any time by full payment thereof, or by making payments to the tax authority pursuant to a payment plan, or under such other conditions as the General Assembly may provide by general law (pursuant to Ga. Const. Art. II, Sec II paragraph III); and that I will not knowingly violate any provisions of the Georgia Election Code (O.C.G.A. Ch.21-2) or of the rules or regulations adopted thereunder.
