

Next Steps from May 3, 2019 Commission and Mayors Meeting

- 1. Adopt the updated Short-Term Transit Plan with project list as presented.
- 2. Pursue alternate funding strategies in addition to a Sales Tax Referendum including state-level strategic investments.
- 3. Complete additional analysis for projects in the short-term update, including ridership projections for GA 400 and economic development potential along South Fulton Parkway.
- 4. Finalize preliminary design and station locations for rapid transit projects in dedicated or managed lanes (GA 400, South Fulton Parkway, I-285)
- 5. Plan voter education process.
- 6. Make go/no-go decision on Nov. 2020 Call for Referendum.
