Firework displays with a proximate audience require an application to the Fulton County Probate Court thirty (30) days in advance to the display date. This application should be submitted to the Alpharetta Fire Marshal's Office thirty (30) days in advance to ensure an efficient review process in partnership with the Probate Court. Upon approval from the Alpharetta Fire Marshal's Office, a permit will be issued to the vendor, pending a site safety inspection from a fire inspector. A representative demonstration of the pyrotechnics may be required to be provided to the Fire Marshal before the permit is approved.

Displays that do not meet the requirements of a proximate display still require an application to be submitted to the Alpharetta Fire Marshal's Office for a permit to be issued.

The Fire Marshal, upon reviewing the required documentation, may require standby fire safety personnel to be present along with operational equipment. The AHJ has the authority to stop the discharge of pyrotechnics/flame effects; the ultimate responsibility for firing shall be that of the pyrotechnic operator.
